This is to certify on June 18, 2008 Squadron No. _____ of The Wisconsin Sons of The American Legion, located in _____, WI has a membership of _____ on which dues have been paid, and therefore under the provisions of The Wisconsin Sons of The American Legion Constitution, said Squadron is entitled to _____ DELEGATES and the same number of ALTERNATES to the 40th annual Wisconsin Sons of The American Legion Convention in LaCrosse, Wisconsin on July 18-20, 2008.

In accordance with Article V, Sections 4-5-6-7-8 of the Detachment Constitution, the following is the procedure in establishing delegates and alternates to the Detachment Convention. **Section 4:** In the Sons of The American Legion, each Squadron shall be entitled to (1) delegate for every (10) members and (1) delegate for any fraction thereof, based on current membership ending (30) days prior to the opening session of the Detachment Convention and (1) alternate delegate for each delegate. **Section 5:** Each duly registered delegate shall be entitled to (1) vote. Alternates for registered delegates shall have all privileges of registered delegates, except that of voting. A registered delegate is one who has received his credentials and has paid such registration fees as may be required. **Section 6:** Delegates from (5) Squadrons shall constitute a quorum. **Section 7:** All Past Detachment Commanders shall be delegates at large to the Convention, with voting privileges with their Squadrons. All Detachment Officers shall be delegates at large with voting privileges with their respective Squadrons. **Section 8:** Where a County and/or District group is organized the Commander shall be a delegate at large with voting privileges with their respective Squadron.

Election starts at 10:30 AM Saturday July 19, Delegates must be present at the time of the election to vote.

DO NOT include DELGATES AT LARGE (DAL) as Squadron Delegates. Delegates at Large include the Detachment Commander, Detachment Vice Commanders, Detachment Sergeant At Arms, District Commanders, County Commanders and Past Detachment Commanders. They are Detachment Delegates and NOT Squadron Delegates.
